Sir:

James McCormick (my brother) one of the sons of Capt. George McCormick, dec^d who was an officer in the Revolutionary war has gone on to your City for the purpose of receiving what may be due to said George McCormick's heirs from the United States; he may probably have a power of attorney from two or three of the heirs, but I take the liberty of protesting against the Department paying over to him any thing which may be due, first for the reason that my father George McCormick made a will the carrying out of which was partially effected by me as a kind of Administrator and secondly there are two or three other heirs who have not signed a power of attorney for him to act.

The will referred to is recorded in the County of Mercer State of Kentucky and it is my intention to settle up the said Estate according to the wishes expressed.

I therefore ask of you to reject the application of said James McCormick & others until I can lay before you evidence sufficient to prove that my interest will be very much affected if he James McCormick has power conferred on him.

 and Comfort Goodright his wife, late Comfort M. Carmichael

 State of Kentucky, heirs at law and legal representatives of
 George M. Carmichael Deed: who was a Captain in the Virginia
 Line of the Army of the Revolution. As hereby constituted and
 appointed George Blinn of the same County and State,
 our true and lawful Attorney, with full power of substitution,
 for us, and in our name to demand and receive from the said
 State the amount of money, Lands or scrips, that may be due
 under right of the services of our said Father George M. Carmichael
 rendered in the war of the Revolution, and our said Attorney and
 Agent is hereby authorized and empowered to receive and
 accept for us each and every of money land or scrips as we
 may hereafter be entitled to receive from the United States or State of
 Virginia for services rendered by our said Father George M. Carmichael.
 and all the acts of our said Agent and Attorney or of his said
 Attorneys, we will fully ratify and confirm by these presents.

five hundred acres of the same
claim to him his heirs and assigns
forever

Item - I give to my Isaac McCormack
five hundred acres of the same claim
to him his heirs & assigns forever

Item - I give to my daughter Betty McCormack
two hundred and fifty acres of the
same land to her and her heirs & assigns
forever

Item - I give to my daughter Comfort Gooding
two hundred and fifty acres of the
same land to her and her heirs or
assigns forever

Item - I give to my daughter Polly McQueen
two hundred and fifty acres to her and
her heirs or assigns forever

Item - I give to my son James McCormack
that fifty dollars I lent him but
but fifty dollars he is to pay

may have an Equal share as have been
Given under my hand and seal this tenth
day of January one thousand Eight

I George McCornick formerly a Captain in
the 13th Virginia Reg^t on the regular continen-
tal establishment during the revolutionary war,
do hereby state on oath that I was commis-
sioned a Captain in the month of July 1777 of the
3^d 13th Virginia Reg^t commanded by Col. William
Crawford of General Mifflin's Brigade
and Genl. Green's divisions, that I faithfully ser-
ved upwards of two years parts of the time as a
Captain previous to getting my Commission and
raised a company of regulars whilst so serving
in 1776 - In the revolutionary war I was in
the battle of Brandywine and there fought as
a Captain in Col. William Bradford's Reg^t and
afterwards I fought in the same Reg^t in the
Battle of Germantown, which Reg^t was then
under the command of Col. William Rufus
and in the fall 1778 I resigned my Commission
when Col. Richard Campbell was promoted Col.
of the Reg^t at Fort Mifflin that I
served during the war occasionally in the
militia service afterwards. When I resigned
I gave up my Commission to Genl. Mifflin
and I have no other evidence by which I can
establish the facts - That I am now dead

and reduced in my circumstances, that I stand
in need of support from my country, I hereby
release all other claims I may have on the
United States for a pension - June the 17th
1818

Madam;

I have to advise you that from the papers in the Revolutionary War pension claim, S. 36105, it appears that George McGarmick or McCormick was Captain of a Company of Virginia Troops, which he raised in 1776, length of service not stated.

He was commissioned in July 1777 Captain and served in Colonel William Crawford's Virginia Regiment and was in the battle of Brandywine. He was in the battle of Germantown, at which time he was Captain in Colonel William Russell's Virginia Regiment, and served until the fall of 1778.

He was also in the Militia, dates and officers not stated.

He was allowed pension on his application executed

June 17, 1818, while a resident of Mercer County, Kentucky, age not stated, and he died January 21, 1820.

The name of soldier's wife is not on record; his children were- Abraham C.; William; Isaac; James; George; John; Andrew; Hetty; Comfort, wife of Michael Goodnight or Goodknight; Polly McGorhan; Elizabeth Crewaor?; Sally Crethen?.
